Notice Concerning Converted Price Adjustment of Zero Coupon Convertible Bonds Due 2018

We hereby provide notice of the adjustment to the converted price of zero coupon convertible bonds due 2018 issued by Sumitomo Forestry as follows:

3. Reason for adjustment

At the 78th(year ended March 31, 2018) regular general meeting of shareholders held on June 22, 2018, a proposed appropriation of surplus for issuing a year-end dividend of 20 yen per share was approved, bringing the annual dividend for the year ended March 31, 2018 to 40 yen per share when combined with the interim dividend of 20 yen. As such, the converted price is being adjusted in accordance with the provisions for zero coupon convertible bonds due 2018.
