Revisions to Organizational Structure and Personnel Transfers

Sumitomo Forestry Co., Ltd. hereby announces that the Board of Directors passed the following resolutions for organizational revisions and personal transfers on November 28, 2025.

I. Organizational revisions (as of January 1, 2026)

1. Establishment of the Real Estate Division

To ensure the expansion of our environmentally conscious real estate business, which contributes to the Wood Cycle with a focus on wooden architecture in Japan and overseas, we will establish the new Real Estate Division to consolidate the real estate business functions currently handled by individual business departments.

(1) Establishment of the Management and Administration Department and the Japan Real Estate Development Department

The Management and Administration Department and the Japan Real Estate Development Department will be established under the Real Estate Division.

(2) Transfers and name changes of the Real Estate Development Department and the Construction Business Sub-Division

The Real Estate Development Department and the Construction Business Sub-Division will be transferred from the Global Construction and Real Estate Division to the Real Estate Division. In addition, the Real Estate Development Department will be renamed the Global Real Estate Development Department.

2. Reorganization of Global Construction and Real Estate Division

(1) Name change of the Global Construction and Real Estate Division

In conjunction with the transfer of the Real Estate Development Department and the Construction Business Sub-Division, the Global Construction and Real Estate Division will be renamed the Overseas Housing Division .

(2) Name changes of the Management and Administration Department and the Asia and Oceania Business Department

In conjunction with the name change as stated in (1), the Management and Administration Department will be renamed the Management and Administration Department, and the Asia and

Oceania Business Department will be renamed the Asia and Oceania Housing Department.

3. Reorganization of Housing Division

(1) Establishment of the Human Resources Management Department

To flexibly implement personnel measures based on the business strategies of the Housing Division, we will consolidate the Human Resources Development Department and the Administration and Planning Department Personnel Group and the Human Resources Management Department.

(2) Separation and name change of the Safety, Environment and Quality Inspection Department

To reinforce risk management concerning housing construction safety and industrial waste, and to develop expertise and clarify responsibilities for response to problems when they occur, the Safety, Environment and Quality Inspection Department will be separated from the Quality Assurance Department and renamed the Safety and Environment Department.

(3) Name change of the Construction Materials Development Department

The Construction Materials Development Department will be renamed the Building Materials Procurement and Logistics Department .

(4) Establishment of a new branch

The Kansai Forest-Maison Branch will be established under the Asset Solution Department.
